Attorneys may be designated by the Supreme Court as "certified attorneys" if they: are able to demonstrate sufficient levels of experience, education, knowledge and skill in a specific area of law or practice; have passed a rigorous examination; and have been recognized by their peers as having sufficient skills and reputation in the designated specialty. Jessica has also recently achieved formal accreditation by The New Jersey Association of Professional Mediators (NJAPM) as a professional Divorce and Family Law Mediator. This Accredited Professional Mediator designation has been achieved by only three other mediators in Monmouth County. In addition, she has acted as an arbitrator in several matrimonial cases, rendering fair and equitable decisions in an efficient and timely manner.

Jessica has successfully taken cases through trial, arbitration, the Appellate Division (see [Hatcher v. Hadiddou](#)) as well as mediation, the collaborative law process, and the Early Settlement Panel, balancing all available litigation options to serve her clients' needs.
